ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of a WELL and RELATED FACILITIES will be received by Clarendon County at the Procurement Department, Room 603 of the Clarendon County Administration Building located at 411 Sunset Drive, Manning, SC 29102 until 2:00 p.m., local time, on **February 14, 2019**, at which time the bids received will be publicly opened and read aloud.

The Project 3B -PATRIOT ROAD WELL consists of providing all required materials, equipment, and labor necessary to complete the construction and installation of a 200 gpm approximately 300' depth groundwater **WELL and WELLHOUSE**. Completed WELLHOUSE shall provide chlorination facilities for the newly constructed WELL, as well as the installation of an existing Clarendon County owned 5,000 gallon hydro-pneumatic tank, related piping, controls and electrical work, site work and fencing.

This project is funded in part by the SC Rural Infrastructure Authority; all local, state and federal mandates shall apply. Bids for 3B -PATRIOT ROADWELL shall be on a lump sum basis as indicated on the bid form. A single prime contract will be awarded.

Bid security of 5% of the bid amount shall be furnished in accordance with the Instructions to Bidders.

BIDS WILL NOT BE CONSIDERED FROM ANY VENDER OWING DELINQUENT BUSINESS PROPERTY TAXES TO CLARENDON COUNTY.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Sections 40-11-10 through 40-11-428). Contractors for shall have a South Carolina License Classification of WL or WP. The Group Limitation shall be Group 4 or above. The Owner respectfully requests that submitting contractors make positive efforts to use local Subcontractors located in Clarendon County. A list of local Subcontractors is available from the Owner by request
